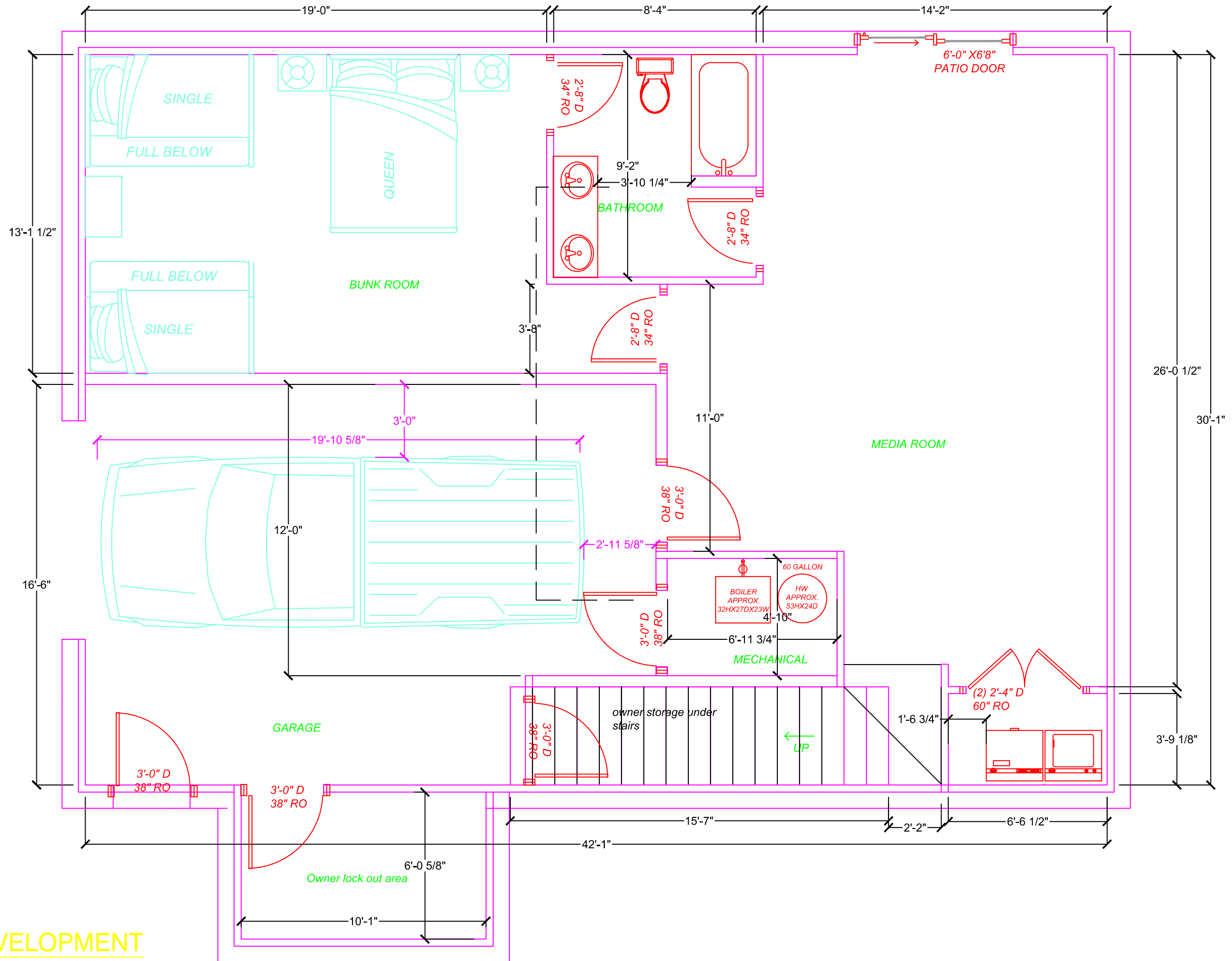

BASEMENT FLOOR PLAN

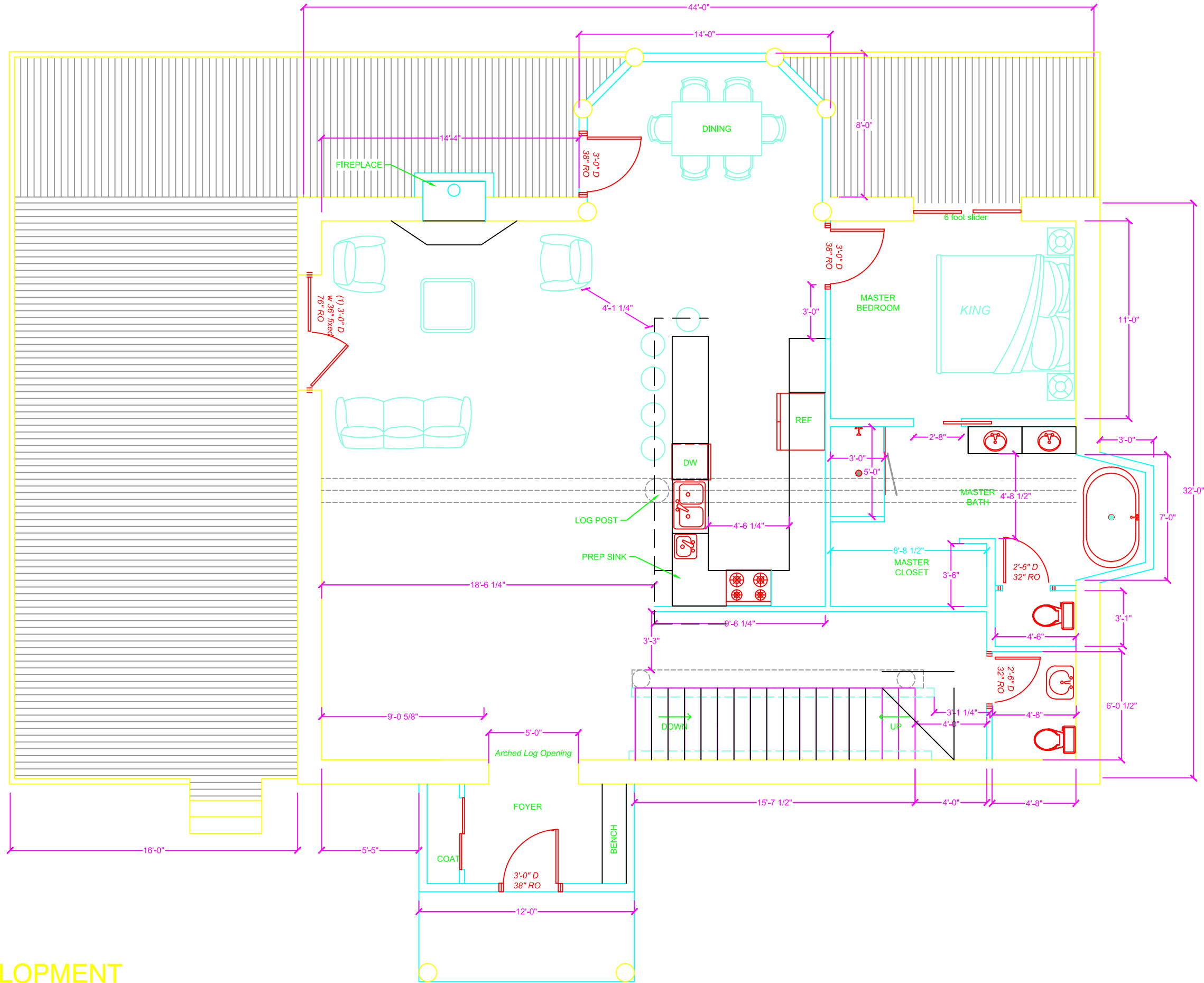

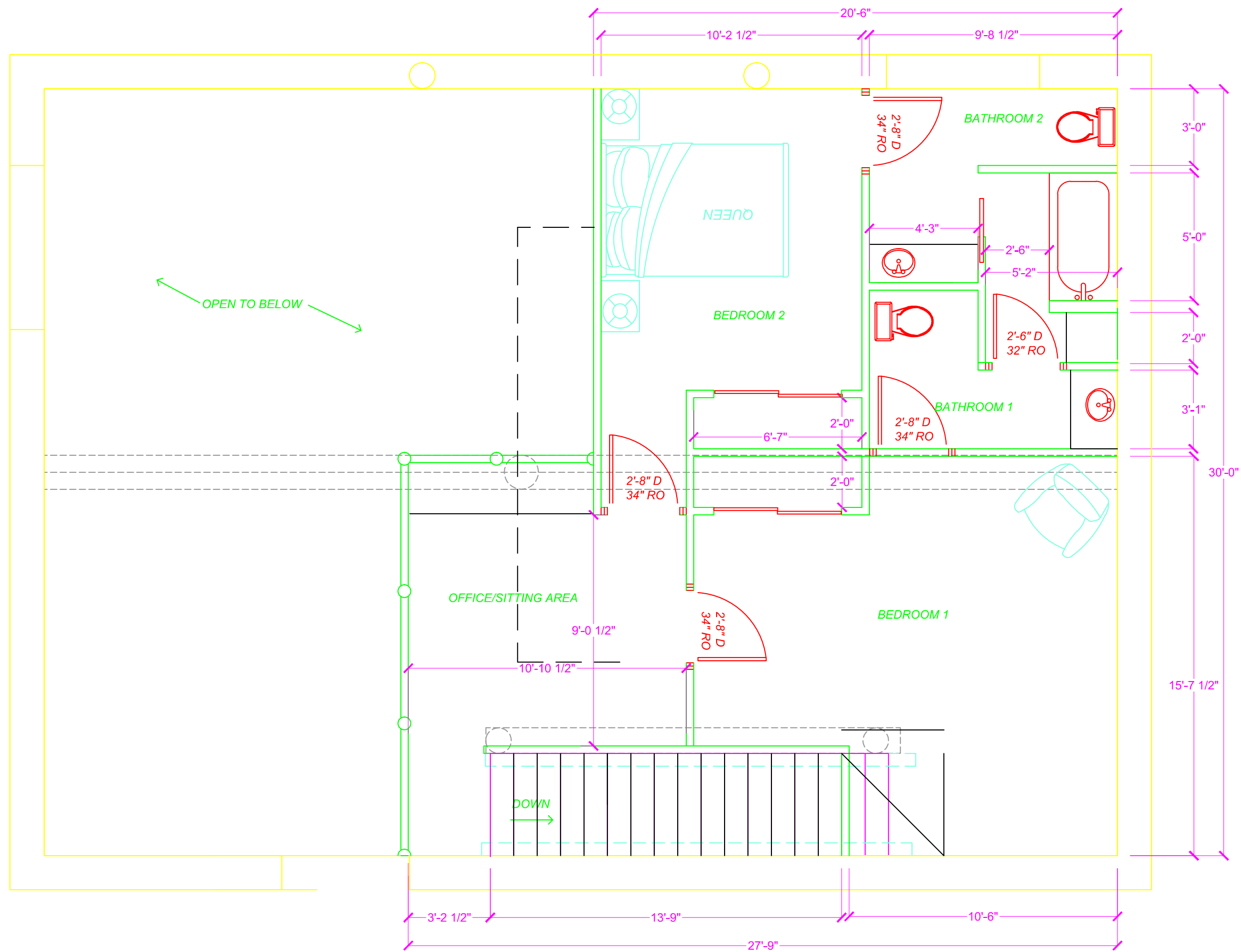
